OFFICIAL RULES AND REGULATIONS
Thursday August 16 to September 19, 2018

NO PURCHASE REQUIRED

1. **CONTEST PERIOD**: The contest *Trouvez Hervé! / Where is Hervé?* (the "contest") starts at 9:30 a.m. Eastern Time ("ET") on Thursday August 16 and closes on Wednesday September 19, 2018 at 5:30 p.m. ET (the "contest period"). The contest period is divided into five (5) entry periods ("entry periods", each "a participating period") as follows:

- 2. **CONTEST SPONSOR:** The contest sponsor is la Ressourcerie des Frontières ("la Ressourcerie" or "the sponsor").
- 3. **TO ENTER THE CONTEST:** Simply visit one or both Ressourcerie stores located in Coaticook and in Magog (collectively "the stores", each "a store"), find Hervé, then complete the entry form at the cash, before the end of the applicable entry period. All entries must include your name, phone number, age, town, email address and the clue of the period. For clarity, Hervé will be located in a different department of each store during each entry period; so, the clue will be different for each entry period. Limit of one (1) entry form per person per week per store. By entering this contest, the entrants automatically agree to accept and abide by these rules. All decisions of the sponsor with respect to any aspect of this contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this contest. All entries become property of the sponsor.
- 4. **ELIGIBILITY**: To enter and to be eligible to win, entrant must be a legal resident of Quebec, aged 18 or more. Employees, officers and agents of the sponsor, their parents, siblings and children, and persons domiciled with them are ineligible to enter.
- 5. **PRIZES:** There are **ten** (**10**) prizes to be won (each "a prize"), five (5) in Magog and five (5) in Coaticook, as follows: two (2) **grand prizes of \$250** (as a VISA prepaid card), one per store (collectively "the grand prizes", each "a grand prize") and **eight (8) secondary prizes**, each a **\$25 gift certificate** redeemable in store, one per entry period per store (collectively "the secondary prizes", each "a secondary prize"). Limit of one (1) secondary prize per person. Total approximate retail value of the prizes: \$700 CDN.
- 6. **PRIZE CONDITIONS:** Prizes must be accepted as awarded EXCEPT that the winner of a grand prize will be offered the choice between the \$250 VISA prepaid card and a \$350 Ressourcerie gift certificate. Sponsor reserves the right to substitute a prize in whole or in part by a prize of the same or greater value. A winner is solely responsible for all costs not expressly described herein. The sponsor will not be held to award more prizes than as set out in these rules.
- 7. By entering this contest the entrants automatically agree to accept and abide by these rules. All decisions of the sponsor with respect to any aspect of this contest, including without limitation the eligibility of entrants and any contest-related information, are final and binding on all entrants in all matters as they relate to this contest.
- 8. WINNER SELECTION: On each of the dates listed below, around 12 (noon), a random draw will take place in each store, from among all eligible entries received during the applicable entry period, or in the case of the grand prizes, among all eligible entries received during the contest period. The first entry drawn will be eligible for the applicable prize. All entries for all entry periods will be entered into the grand prize draw.

The odds of winning a secondary prize depend on the number of eligible entries received in the store during the applicable entry period. The odds of winning a grand prize depend on the number of eligible entries received in each store during the contest period. The sponsor, acting reasonably, will attempt to contact the potential prize winners by email or by phone, at the e-mail address or phone number provided as part of the entry, within two (2) business days after the draw to notify them that they may have won the prize draw (the "winner notification").

The sponsor reserve the right, in his sole discretion, to disqualify any individual they find to be tampering with the entry process or the operation of the contest or to be acting in violation of these rules or otherwise in a disruptive manner (such as is described above) by using or relying on any evidence or other information made available to, or otherwise discovered by, the sponsor. Any attempts to deliberately damage or undermine the legitimate operation of this contest is a violation of criminal and civil laws and should such an attempt be made the sponsor reserves his right to seek remedies and damages to the fullest extent of the law. - 10. **TERMINATION/MODIFICATION:** If for any reason, in the opinion of the sponsor, in his sole discretion (subject only to applicable law and the consent of the *Régie des alcools*, *des courses et des jeux du Québec* (RACJ)), the contest is not capable of running as originally planned, or if the administration, security, fairness, integrity or the proper conduct of the contest is corrupted or adversely affected, including by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other causes beyond its control, sponsor reserves the right (subject only to applicable law and the consent of the RACJ) to cancel, terminate, modify, amend, extend or suspend the contest, and select a winner from among all eligible entries received up until the time of cancelation, termination, modification, amendment, extension or suspension. Sponsor reserves the right to modify these rules without materially affecting the terms and conditions hereof.
- 11. Any litigation respecting the conduct or organization of this contest may be submitted to the *Régie des alcools*, *des courses et des jeux du Québec* for a ruling. Any litigation respecting the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.
- 12. **COLLECTION AND USE OF PERSONAL INFORMATION:** By entering this contest each entrant consents to the collection, use and distribution of his/her personal information by the sponsor for the purposes of administering this contest and, if consent is given at the time of entry, to provide the entrants with marketing information from la Ressourcerie. Odds of winning a grand prize depend on the number of eligible entries received during the contest period. Mathematical skill testing question required.
